Temperature Monitoring Services



- To help verify and monitor the health and well being of our employees and building occupants.
- Testing available prior to each shift. Employees testing above 100.4° are sent home prior to entering the workplace.

Frequent Hand Washing Education training our employees on CDC and WHO sanctioned 4-point process



- Wash your hands often with soap and water for at least 20 seconds especially after you have been in a public place, or after blowing your nose, coughing, or sneezing.
- If soap and water are not readily available, use a hand sanitizer that contains at least 60% alcohol. Cover all surfaces of your hands and rub them together until they feel dry.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Hand sanitizer are available for all our employees working on-site.

Social Distancing Practices



Social Distancing is always required (6 ft between employees/tenants), upon entering the workplace - clocking in and in break rooms, while on the floor cleaning, and when leaving an employee's shift.

- The International Sanitary Supply Association (ISSA) The Worldwide Cleaning Industry Association offers an online Microbial Warrior Workshop. This education and on-line certification process through its division of the Global Biorisk Advisory Council (GBAC) provides education directly about teaching cleaning professionals to prepare for, respond to and recover from biohazards in the workplace and infection and contamination control measures.
- We are certifying managers in each of our markets and have developed additional internal training courses for each of our employees that will be providing specialty disinfection services.
